QUOTE RECOMMENDATION

BACKGROUND:

We request that the MISD Board of Trustees approve the recommendation as made by the Purchasing Department, in conjunction with the Student Nutrition Department, for awarding Buyboard Quote #11-079 for Student Nutrition Serving Lines. The quote was received from a pre-approved Buyboard vendor, Texas Food Service Equipment. MISD is a member of the Buyboard Cooperative purchasing group. The Local Government Purchasing Cooperative is an administrative agency created in accordance with Section 791.001 of the Texas Government Code.

CONSIDERATIONS:

Attached is the tabulation of the quotes received. The purpose of this quote is to obtain new serving lines for Alice Ponder Elementary, J.L. Boren Elementary, Charlotte Anderson Elementary, Glenn Harmon Elementary, and Summit High School. The current serving lines at these schools are outdated and require high maintenance. Additionally, they do not comply with the latest Texas Department of Agriculture (TDA) Texas Public School Nutrition Policy. Kiosks were also quoted for Timberview High School and Mansfield High School and may be purchased to accommodate the expected enrollment increase.

RECOMMENDATION:

The Purchasing Department recommends that the quote for serving lines and kiosks be awarded to Texas Food Service Equipment as shown on the quote tabulation.
