- IV. **Presentation of Attendance Zone Sub-Committee Recommendations**
 - a. What do we need to do? We need to adjust attendance zones north and west because of the growth in the south and east parts of the district.
 - b. It impacts every high, middle and intermediate school in the district
 - i. **Elementary Schools:** No elementary zone's change in proposed plans at this time but could come back to it in a few years.
 - ii. **Intermediate/Middle Schools:** proposed changes will impact all schools – not dramatically - but enough to shift some students to the north to avoid overcrowding of schools in south portion of district.
- V. **High Schools:**
 - a. **Current zoning map:** Lake Ridge, Legacy and Mansfield either at capacity or becoming overcrowded.
****Please Note – Due to an error in demographer maps, the numbers presented with the current high school zone map may be slightly modified. Staff are working with demographers to update the numbers according to the correct current high school zone map. ****
 - b. **Plan 1 High School Zone**
 - i. Lake Ridge's zone is entirely east of 360. Legacy's zone moves north and Mansfield's zone comes south in order to take some enrollment burden from Lake Ridge. MHS now picks up McKinzey and Martinez. Summit regains all of Holt, Tipps and part of Nancy Neal. Reid shifts to Timberview HS.
 - ii. Legacy numbers may surpass capacity in 2031.
 - c. **Plan 2 High School Zone**
 - i. Same as Plan I except Neal attendance zone stays intact with Legacy feeder pattern.
 - ii. Only concern for crowding is Legacy with potential in 2031-32.
 - d. **Plan 3 High School Zone**
 - i. Lake Ridge zone comes west across 360, Daulton shifts to Timberview pattern. Reid stays in Mansfield High School zone.
 - ii. Numbers look good in this plan across the board.
