



OPTIONAL Non-Refundable Device Protection Program 2023-2024

Fall of 2023, Mansfield ISD will provide students in PK-4 a device that will be used at school and will remain in classrooms. Students in grades 5-12 have the option to request a district-issued device that they will be responsible for care and upkeep. Devices will be assigned based on the program of study that the student is enrolled in. Providing parental consent below allows your 5th-12th grade student the ability to request a district-issued device, as well as optional device coverage.

Mansfield ISD will continue offering an optional device protection program for students who have utilized district-issued Chromebooks and laptops. The program will cover devices used by students in grades 5-12. Parents/guardians will have the opportunity to register for optional coverage when their students are enrolled in Skyward.

This **OPTIONAL Non-Refundable Device Protection Program Fee** can be paid to cover accidental damage for the first incident and provide discounts for subsequent accidental damage incidents. *If you choose not to pay the OPTIONAL Non-Refundable Device Protection Fee you are responsible for repair or replacement fees as identified in the table below.*

Please see details below about the program:

- Parents/guardians and students must acknowledge and consent to the [Student Device Management Handbook](#), as well as the [MISD Student Handbook](#) prior to participating in the program. Acknowledgement to both handbooks is a regular part of the registration process each year.
- Parents/guardians are encouraged to review this agreement with their students prior to registration, as parental consent also includes student consent.
- Once **enrollment and registration** have been approved by the district, you will be eligible to access and submit a form in Skyward to participate in the **OPTIONAL Device Protection Program**. Families can access the form by going to Skyward Family Access and selecting the identified form at the top of the page.
- After the enrollment window ends, a program fee will be applied to your child's account via Skyward Fee Management.
- Program registration opens **during district open-enrollment and will end September 1, 2023.** **Starting on September 5, 2023,** coverage fees will be added to the Skyward account of those opted-in. Once the fee is added, families will receive an email

notification. At that time, we ask that payment is made in the Skyward portal within 30 days. Payment is required to be fully covered.

- Program protection will not go in effect until after the Skyward fee has been **paid in full. Coverage lasts for one school year which will span from the first date of enrollment until August 14, 2024.**
- Parents/guardians will have **30 days to pay the opt-in fees** once they have been added to Skyward. After the 30-day window, all optional coverage fees not paid will be removed from student Skyward accounts, and the ability to opt in will be forfeited.
- **Students with outstanding technology fees must pay their fees prior to opting into the program.**

REMINDER: If you choose not to purchase the Optional Device Protection Program Entry Charge, you are responsible for **the fees outlined below** for the repair or replacement. See table below for costs associated.

NOTE: Per the MISD Device Handbook, students/guardians should never try to repair a district-issued device or have someone outside the district work on the device. Replacement devices must be purchased via the district.
